If any project is commenced prior to the appropriate permit being issued or a public hearing action being approved, all applicable fees shall be **tripled or 2% of the project cost, whichever is greater. In the case of a minor structure, where there is no fee, said after-the-fact fee shall be **\$300.00**

When WI Dept. of Commerce program administration & WI DNR groundwater fees are amended, the corresponding increase shall automatically be reflected in the total sanitary permit fees collected by the county. The PD&Z Committee may waive the Conditional Use Permit fee for public and semi public buildings.

The PD&Z Committee may waive or reduce the Conditional Use Permit fee for Type II Comprehensive Plan Revisions.
